APOLOGY – Mountain Bikes in Waitakeres

Sorry I misread this document and the information last month did not apply to the Waitakere Ranges.

The following is correct.

A draft amendment to the management plan concerning the use of mountain bikes in Regional Parks including the Waitakeres has been released.

The new draft policy would apply to biking in the parkland (including Lake Waimanu Reserve and the Catchment Parkland).

The recommendation is for non motorised bicycles to be prohibited from the Waitakere Ranges Regional Parkland.

DOGS

Uncontrolled dogs are frequently a source of concern in both urban and rural areas.

The Dog Control Act 1996 sets out in detail a dog owner's responsibility to control his or her dog and the consequences that may follow from lack of control.

A dog is required to be registered and kept under control at all times. The Act provides that a dog can be considered not under control if it is

found in any public place in contravention of a bylaw or on any private land without the consent of the occupier or owner of that land

Many local authorities have bylaws which require dogs to be on a lead when in any street or public park or other public place. The local Council office will be able to advise and show you a copy of their particular bylaws.

If a dog is not under control in terms of these provisions a dog ranger may seize the dog. If a dog has entered private property the occupier of that property may seize the clog. Anyone in a public place may seize a dog if it is likely to cause annoyance or distress to any person or damage to any property. Having seized a dog that person must then return the dog to its owner, or make sure that a dog ranger takes it.

Attacks on Stock

A person has power under the Act to destroy a dog, but this power should be exercised with caution. It arises only when a person can actually see the dog attacking stock, poultry, another person or is personally being attacked.

It is important for stock owners to remember that their legal right to destroy a dog attacking their stock only applies if they actually see the dog attacking their stock. It is not sufficient to suspect a particular dog may be

one that attacks stock, or to "catch up" with the dog a few days later. However, stock owners do have a further right to seize or destroy a dog if it is running "at large" amongst their stock The stock owner must show that the dog was actually running with the stock, or if left at large would return to run with them.

Dog rangers and police officers have much wider authority to enter on to private property and to seize and destroy dogs which may have been attacking stock. Courts have extensive powers to order destruction of such dogs and impose fines or sentences of imprisonment on owners of offending dogs.

Barking Dogs

Dogs which bark persistently can be a considerable nuisance. A complaint of this sort should be referred to the dog ranger The Act contains powers for the ranger to enter onto private property, give notice to the owner, and if the notice is not complied with, remove the dog.

Liability for Damage

The owner of a dog will be liable for any damage done by the dog.

The Piha service is also improved with route 159 leaving Henderson on Wednesday and Friday at 8.55 am and arriving at Piha at 9.35 am

Also leaving Henderson at 1.55 pm and arriving at Piha at 2.35 pm.

From Piha to Henderson on Wednesday and Friday are at 9.35 am, arriving at Henderson at 10.20 am and 2.35 pm, arriving Henderson, 3.20 pm.

Route 159 departs from Great North Road (Henderson Township) and travels via Great North Road, Railside Avenue, Bruce McLaren Road, Parrs Cross Road, West Coast Road, Scenic Drive, Piha Road, Seaview Road, Beach Road, to Post Office Store (Piha).

It is not necessary to prove that a dog has previously caused damage or injury or that the dog owner knew that it had a tendency to cause damage. Nor is it necessary to prove any neglect on the part of the dog's owner.

This means a dog owner would be liable for any damage caused even if the dog were on a lead at the time.

To give a few practical examples:

- If you find a strange dog on your property and in your view it is likely to cause annoyance or distress, perhaps to you or your children, you may seize that dog. However, you would have to return it to its owner or contact the dog ranger.
- If a dog is wandering on the street or in a public park and it appears unlikely to cause annoyance or distress to anybody, then the most you can do is to contact a dog ranger.

In view of the way that the Dog Control Act is drawn, I am of the opinion that merely because a dog chooses your front lawn for its convenience does not give you the right to seize the dog or make any complaint to a dog ranger. However, many local authority bylaws impose more stringent criteria in an attempt to meet this particular nuisance.
